Course Name - Phonetics and Spoken English

Class - Ma English Semester - I

Objectives of the Course

This primary objectives of this course are

- 1)To provide theoretical knowledge and practice about basic concepts in Phonetics
- 2] To enable the students to acquire phonetic skills required for correct pronunciation.
- 3] To impart knowledge about the phonological structure of modern English.
- 4] To provide information and practice in word accent and speech rhythm and intonation of various accents.
- 5] To give training to students in listening and speaking of sounds to help them overcome mother tongue interference.

COURSE OUTCOMES

Intellectual cognitive/Analytical skills -The analytical/cognitive capabilities and skills of the

students are enhanced in the following areas. They gain insight into:

1) phonological systems and accents of different languages.

2)the pronunciation of individual phonemes, syllables and words in RP English and others

accents

3) The rhythmic patterns of English language and its differences from other languages and

accents

4) Patterns and functions of English intonation.

pronunciation of consonants, vowels and diphthongs and also help the students to minimise the

mother tongue influence in their speech. The students better comprehends foreign accents and

Course Name: MODERN NOVEL

literature with the British and Indian literature.

Course Name: General Linguistics

Programme : MA English Semester: III

Objectives of the Course:

This course aims at acquainting students with linguistics as the science of language study, its

aims, aspects and relations to other social sciences and fields. It also aims at acquainting students

with the nature of human language and its characteristics, components and functions.

Course Outcomes:

A. Knowledge and Understanding:

Students will

• know how to define the various branches of linguistics (e.g., phonetics, phonology,

morphology).

• understand and explain the basic concepts associated with the different branches of

linguistics (e.g., dialect in sociolinguistics, morpheme in morphology, parts of speech in

syntax), and

Students will understand and be able to describe the differences between the various

linguistic levels

B. <u>Intellectual(Cognitive/Analytical) Skills</u>:

Students will be able to

• identify the phonetic properties of words, phrases and sentences (e.g., stress),

• analyze words, showing their structure through pointing out the root, the stem, the

derivational and inflectional morphemes and the free and bound morphemes that combine

to form words in language,

• analyze sentences, showing their structure and their constituents,

analyze sentences, showing the semantic roles realized by the different constituents in

each sentence, and

• think critically about the different theories of language acquisition.

C. Practical Skills

• Draw trees diagrams to show sentence structure, which is a basic skill in syntax,

• Assign the appropriate word formation processes to a variety of words with different

forms, and

Course Name: Indian Writing in English

To expose students to the significance of Indian writer's use of English for creative expression.

Critically analyse the prescribed texts.

Draw upon varied and relevant sources to get an insightful understanding of the prescribed texts.

Understand key issues and themes in Indian writing in English.

Appreciate the structural and stylistic Innovations in Indian writing in English.

Have an insight into feminism in Indian writing in English as three out of five writers prescribed in the course are woman writers.

Course Name – Rhetoric and Advanced Composition

Class -MA English Semester - III

Objectives of the Course

This primary objectives of this course are

- 1)To provide theoretical knowledge and practice about basic concepts in Rhetoric and Advanced Composition
- 2] To enable the students to acquire language skills required for effective writing.
- 3] To impart knowledge of different language structures of English language.
- 4] To give training to students in writing in an organized manner.

COURSE OUTCOMES

Knowledge and understanding -The students gain knowledge in the following areas:

- 1)Knowledge of basic concepts in Rhetoric and Advanced Composition.
- 2)Understanding of various techniques and strategies of writing paragraphs.
- 3)Understanding of using different language structures-to make their writing effective.

Intellectual cognitive/Analytical skills -The analytical/cognitive capabilities and skills of the students are enhanced in the following areas. They gain insight into:

- 1) Different kinds of writings like narrative argumentative expository etc and their characteristic features.
- 2) Various techniques of paragraph development defining, comparing contrasting etc.
- 3) Common language errors committed by users of English language.

Practical skills

effective use of language and also help the students to minimize errors in their writing.

Course Name: Modern Literary Theory and Criticism

Programme : MA English Semester: IV

Course Objectives

This course explores a range of theoretical ideas and concepts that have shaped Literary studies

today. It provides students with grounding in some of the major theoretical methodologies in

literary studies. These include post colonialism and postmodernism, psychoanalysis,

deconstruction, feminism and queer theory, and historical and cultural materialist approaches to

literary texts. The course will examine important themes in literary interpretation including

character, voice, narrative, and genre.

Program Learning Outcomes:

At the end of the course students should be able to achieve following outcomes:

1) Identify major theoretical/critical movements and theorists, as well as primary concepts with

which they are associated

2) Define and apply specific theoretical concepts, theories, and terms to literary and cultural texts

3)Demonstrate an understanding of important theoretical methodologies by summarizing key

concepts or arguments

4)Apply these concepts or arguments successfully in a close reading of a literary text.

5)Use online databases to define key terms and trace implications in source texts.

6)Evaluate and analyze strengths and limitations of critical/theoretical arguments.

7) Examine historical contexts for the development of contemporary theory and criticism.

8)Strengthen and deepen critical reading, writing, and interpretive practices.

Course Name: American Literature

Class: MA English Semester IV

Objective of the course: To introduce the students to American literature

Course Outcomes:

a) Knowledge and understanding; To orient the stud6to the genres of poetry, novel and drama in

American literature.

b)Intellectual cognitive/ analytic skills: Critical analysis of the texts prescribed and historical,

social, cultural and psychological insights into them.

c)Practical skills: Narrative, descriptive and analytical skills related to the various genres under

study.

d)Transferable skills :Analysis of life and literature.

Course Name: Prose and Short Stories

Class: M.A. English

Semester: IV

Objective of The course:

Teaching prose and short stories means teaching reading with comprehension. The students are

taught the skill of reading. And reading with comprehension helps the students to acquire new

vocabulary and content words.

Teaching prose enables the students to understand the passage, to read fluently, to enrich their

vocabulary and to enjoy reading and writing. It enables the learners to extend their knowledge of

vocabulary and structures and to become more proficient in the four language skills. It develops

the ability of speaking English correctly and fluently.

The main aim of teaching prose is to develop the language ability of the students. It is the

intensive study of a language. The language ability helps the learners to use English language

without any problem.

Course Outcomes:

e) Knowledge and Understanding: The students will be able to:

• To understand the passage and grasp its meaning.

• To read with correct pronunciation, stress, intonation, pause and articulation of voice.

To enable students to understand the passage by silent reading.

f) Intellectual Cognitive /Analytical skills: The course provides students better opportunities

to develop reading and writing skills and they will be able to:

To express the ideas of the passage orally and in writing.

To enjoy reading and writing.

• To develop their imagination.

g) Practical skills: The course provides better acquaintance of various literary devices used by

the authors in their works and they can do the scanning of information, paying attention to

the writer's intensions, arguments, ideas, style, etc., The students will be able to answer all

questions which involve their understanding of the text, grammar, vocabulary, writing, etc.,

h) Transferable skills: The course helps in analyzing (comparison and contrast) various works

by different authors/ writers of great repute. The students will be able to know about their

narrative techniques and skill of expressions.

Course Name : Post Colonial Literature

Class : M.A. English Semester: IV

Objectives: This Course intends to acquaint the students with some seminal works of

postcolonial literature. These are: Things Fall Apart, The Ice-Candy Man, Surfacing and Wild

Sargasso Sea. Though all these texts deal with diverse regions and socio – cultural contexts,

they, for a common history of colonial oppression, largely share common concerns and

strategies. Significantly these texts reveal, by and large, fundamental themes, discourses and key

structural and stylistic features of post colonial literature.

Learning Outcomes: Reading of the prescribed texts will enable the students to

understand many thematic concepts which are quite connected

with both 'colonizer' and 'colonized'.

Students will stand familiarized with the literature of resistance,

critique, transformation and emancipation. As out of the four

writers in the course, the three are women ones, the students will

have an insight into postcolonial feminism.

Course Name: World Classics in Translation

Class: M.A. English

Semester: IV

Objective

This paper aims at acquainting students with the select and representative world classics in

translation. It also aims at familiarising students with the major literary trends reflected in these

classics.

Outcomes

After going through the paper, the students will be able to know about the major trends reflected

in representative literary works.

The students will have in-depth understanding of the concepts of alienation, existentialism,

realism and naturalism. The students will also be able to understand a particular literary work

applying different approaches such as Marxist, socialist and existentialist. The student will also

be able to know about the features of a dystopian writing.

Course Name: Greek Literature

Class: M.A. English Semester: IV

Greek Literature

Objectives: This paper aims at providing information to students about the Greek classics in English translation. It also intends to provide students information on the various aspects of

Greek tragedy and enables them to understand the difference between tragedy and comedy.
