


















WHAT IS YOUR OPININ ABOUT THE LIBRARY MATERIAL AND FACILITIES


PARAMETER - VI: TO WHAT EXTENT WERE YOU ABLE TO GET MATERIAL




DOES THE COURSE NEED TO BE MODIFIED?

The students opine that their course is at par with courses available in other universities. 39% of the students said the same course at other universities is equal with theirs. 41% said it can't say. 15% consider it more updated and only 5% said it less updated.

Conclusion- The students are happy with the content of courses taught to them. For majority of the students the courses are easy to understand while some think it otherwise. The students are satisfied with the amount of syllabus covered in class. The students are of the opinion that the

availability of study material is satisfactory. Few students share the opinion that the course should be modified.

1.1 Introduction: The purpose of this parents' feedback is to make the teaching learning process more effective in context to job market and analyze applicability of course in real life. It also examines the parents' views on overall development of their wards and how students deal with the academic workload and demand of the course. The target sample of this feedback form is parents' of different cultural and economic backgrounds and regions. The mode of feedback is manual. However, online feedback form is also available.

1.2 Summary: This feedback by parents is based on the parameters. For example, relevance of the course content to the job market, length of the syllabus availability of the reading resources, workload comfort of the wards, usage of technology in teaching, improvement in the personality of the wards and practical aspect of the course. These parameters are counted on four point scale. After the findings and discussions, it is formulated that the parents highly rate the course and its relevance in the job market and practical applicability in life.

2.1 Findings:

2.1.1 Parameter I Relevance of the course contents to the job market: 43% of the parents believe that there is very good relevance of the course contents to the job market. Nearly, 34% affirm it is good and 19% accept it as satisfactory. Zero % unsatisfactory response by parents' confirms the strong relevance of the course content to the job market in the current scenario.

2.1.2 Parameter II Coverable Length of the Syllabus: 34% of the parents affirm that the syllabus of the course is coverable and is very good while 41% of the parents deem it good. On the other hand, 19 % parents consider the length of the syllabus satisfactory and 6% parents are unsatisfied with the length of the syllabus.

2.1.3 Parameter III Availability of the course books and study materials in the market: 44 % of the parents agree that books and materials for the course are available in a very good

amount and same % believe it to be available in good number. While, 12% of the parents are satisfied about the availability of the books and materials in the market and 3% remain unsatisfied about availability of reading sources.

2.1.4 Parameter IVDegree of comfort of the ward in coping up with the workload: 22% of the parents opine that workload comfort of the ward is very good and 53% of the parents feel it is good. Moreover, 19% Parents are satisfied with the workload of the ward. However, only 6% parents are unsatisfied with the workload comfort of the ward.

2.1.5 Parameter Inclusion of Technology in Course: 31% parents agreed that technology which is used in the course is very good and 44% believed that it is good. While, 16% Parents are satisfied with the use of technology in the course. But only 9% are unsatisfied with the ICT usage in the course content.

2.1.6 Parameter VI Improvement in personality of wards: 44% Parents feel that personality of wards have improved in a very good manner. Additionally, the same percentage of parents believe it is good. While, 9% parents are satisfied with the improvements of the wards. However, 3% are unsatisfied with this view.

2.1.7 Parameter VII Applicability of course content in practical life: 43% of parents acknowledge that the content of the course is very good and real cum applicable in our day to day life. Almost same majority of the parents reason, it is really good and concrete. Further, 9% parents are satisfied with its applicability in our real life. There was zero % of parents who were unsatisfied with its relevance in real life.

2.1.8 Parameter VIIIOverall Rating:50 % of the parents rate the course and its content as very good and 41% rate it is good. 9% consider the course is satisfactory. However, no one is unsatisfied with its overall rating.

3.1 Discussion: After analyzing the 08 parameters of parents' feedback, we can confirm that most of the parents are highly satisfied with the relevance of the course and its applicability and overall rate it highly which is encouraging to the efforts made by the college management. Considerable number of parents opine that sufficient number of course books and reading materials are available in the market and the course is successful in improving the personality of the wards. Significant number of parents and agree with the workload comfort and the length of syllabus of the course.





Ques. 2: Extent of coverage of course



However some current area of economic research (like topics from behavioral economics and welfare economics) can be added to enhance the coverage of the course.




Ques. 3: Applicability/ Relevance to real life situations


Ques. 4: Learning value (in terms of knowledge, concepts, manual skills, analytical abilities and broadening perspectives)


Ques. 5: Clarity and relevance of textual reading material


Ques. 6: Relevance of additional source material (Library)


Ques. 7: Extent of effort required by students




Ques. 1: The syllabus of each course/paper was



Ques. 3: Was the course easy or difficult to understand




Ques. 4: How much of the syllabus was covered in the class?


Ques. 5: What is your opinion about the library material and facilities for the course?



sometimes face some difficulty as books are not so readily available in the market. But department usually provides handwritten notes and other latest material to students to cover the contents of the course.




Ques. 7: Does the course need to be modified?





Ques. 8: On coming across students doing the same course at other universities you find their course contents


Ques. 7: Does the course need to be modified?

As far as modification of course is concerned, 20 percent students reported that course need not to be modified and 35 percent wanted it to be modified. However 45 percent said that less than 50 percent of the course needed to be modified. So it is suggested that topics irrelevant to the contemporary economic world should be removed and current economic topics of which students should be awared of must be added.




Ques. 8: On coming across students doing the same course at other universities you find their course contents


